

Privacy Notice

Effective Date: January 3, 2018

This privacy notice discloses the privacy practices for **Leather List** and its website <https://www.leatherlist.org>. This privacy notice applies solely to information collected by this website, except where stated otherwise. It will notify you of the following:

- What information we collect;
- With whom it is shared;
- How it can be corrected;
- How it is secured;
- How policy changes will be communicated; and
- How to address concerns over misuse of personal data.

Information Collection, Use, and Sharing

Leather List is the sole owners of the information collected on this site. We only have access to/collect information that you voluntarily give us on the site. We do not sell or rent this information to anyone.

We will use your information to respond to you, regarding the reason you contacted us. We will not share your information with any third party outside of our organization

Your Access to and Control Over Information

You may opt out of any future contacts from us at any time. You can do the following at any time by contacting us via the email address or phone number provided on our website:

- See what data we have about you, if any.
- Change/correct any data we have about you.
- Have us delete any data we have about you.
- Express any concern you have about our use of your data

Registration

During registration a user is required to give certain information (such as name and email address). At your option, you may also provide additional information (such as gender or age) about yourself, but it is not required.

Contributions

We display information from you on our contribution cart. To contribute, you must provide contact information (like name and address) and financial information (like credit card number, expiration date) to a third party, PayPal, Inc. This information is used for

billing purposes and to complete your contribution. If PayPal has trouble processing a donation, they'll use this information to contact you. You can contact them at any time.

Sharing

We have no agreement with any party to share any information. This is not linked to any personal information that can identify any individual person. Nor can it be used to access any credit or bank account.

L L uses PayPal, an outside payment processing company, to charge donors for their donations. These companies do not retain, share, store or use personally identifiable information for any secondary purposes beyond completing the donation.

Security

We take precautions to protect your information. When you submit sensitive information via the website, your information is protected both online and offline.

You can verify this by looking for a closed lock icon at the bottom of your web browser, or looking for "https" at the beginning of the address of the web page.

While we use encryption to protect sensitive information transmitted online, we also protect your information offline. Only Leather List Officers who need the information to perform a specific overall data analysis are granted access to aggregated contribution data. The computers/servers on which we store personally identifiable information are kept in a secure environment.

Cookies

We use "cookies" on this site. A cookie is a piece of data stored on a site visitor's hard drive to help us improve your access to our site and identify repeat visitors to our site.

For instance, when we use a cookie to identify you, you would not have to log in a password more than once, thereby saving time while on our site. Cookies can also enable us to track and target the interests of our users to enhance their experience on our site. Usage of a cookie is in no way linked to any personally identifiable information on our site.

Some of our business partners may use cookies on our site (e.g., advertisers). However, we have no access to or control over these cookies.
